1. Prospective merchant receives application forms, Nashville Farmers Market rules and regulations and new vendor package.
2. Merchant submits a completed application, business plan, product and equipment list and signed Rules and Regulation receipt.
3. Interview with Market Director, review of available spaces.
4. Prospective merchant presents architectural drawings of desired space, detailing layout of merchandise, utility, venting and on-site storage.
5. Lease negotiations with Market Director.
